Details of the Judges Work: (including judging statistics)	This was the largest FAI ISC Speed Skydiving event to date with 61 competitors. The atmosphere was exciting, and the competitors came prepared to win. And win they did, with a total of 23 new G1 Competition Records and 4 G2 Performance Records set! That may be a record itself! All judges worked together as a team and I am very proud of how well we kept the meet moving and scores quickly generated. This was Mike Pennock's first Speed meet and he did an outstanding job as did Angelika in all areas. Barrie also did an excellent job and demonstrated a command of the judging flow, and I recommend Barrie for a CJ position.
Recommendations for Organisers:	Our Organisers Reinhard Flatz, Alexander Kantner, and their team were extremely helpful and a true pleasure to work with. On behalf of all meet officials I cannot thank them enough for everything they did and the wonderful hospitality we were shown, and I certainly recommend this as a superior facility for hosting future FAI ISC events.
Rule Changes – Proposals:	While I do not have any specific rule change proposals, I do have a recommendation for any Speed CJ with respect to the scoring system operation. We used InTime for this event, and it performed flawlessly. It is a superior system that has proven itself. The issue is if any software modifications or changes are necessary (as we had to perform at this event) this could lead to possible scoring and data problems if the modifications fail. The original system required modification to add another "event" that was recently added called Mixed Team. Our TSD and panel judges had both extensive InTime and software experience which proved invaluable for the necessary changes. Although we backed up everything including the Flysight jump data before modifying the system, it was possible that the system and all the scored rounds would need to be restored if the upgrades failed which had the potential to delay the competition. Fortunately, the upgrades were completed without incident. Because of this experience, it is my strong recommendation that unless the TSD and/or panel judges have significant software and experience with the

	exact scoring system used, that a representative of the scoring system company be required to be on site.
